There will be 4.5 acres across the road with the blueberry patch and 4.26 remaining acreage with the vineyard and the house. New rods have been set. There is a total of 56 ft. of road frontage and the well and septic are on the maps.

The Planning Board granted final approval.

Kate and Chad Gulley - 117 Petteys Rd. tax map #246.-1-39.1 - 34.7 acres will be dividing out approximately a 1-acre lot for his mother Carol Gulley. Survey map was presented and Planning Board liked the looks of everything so they gave permission to move on to PH September 3nd meeting.

- Have one culvert on Wright Road that need to rent a bigger excavator from Capital. The culvert is way down and a lot of cement surrounding. A 2-day rental is over \$1000.
- The Highway Superintendent has had a request of a speed limit reduction on Oak Hill (Stage Road). This would start at Eric & Margaret Shaws and make the turn and go down to the Old Bobby Harrington farm. Possibly drop down to 40 mph.
- Supervisor Fedler said have to request a speed patrol and after that the speed sign is placed for speed study. This process could take up to year or more.
- Final round of CHIPS paperwork has been submitted.
- An EZ Pass bill received but not for the Town of Cambridge, says the pickup truck May 11th at 11:00 but the picture doesn't match the Town pick up. The Highway Superintendent took care of online and says could take up to 4 weeks.

County Report

The Town Supervisor reported that County Budget scary and nasty not going to be pretty this year. She said that the Sheriff Dept. and the DPW are the only ones that aren't mandated. Dept. of Social Services DDS are mandated. County Route 60 is not going to be paved until beginning of September.
