The pile is freezing because it has water in it and has 5% non-sodium chloride which is non salt. Highway Superintendent reported that he has spoken with the company and they are planning on giving a certain percentage of refund back, not sure how much yet. Governor Hochul is saying that have to buy American Salt. He mentioned that this year have American Salt but in previous years have had Morton and Atlantic Salt which are better.

The Supervisor mentioned that Solar companies are buying up land for just battery storage new thing that came out of nowhere.

Town Board

Councilman McIntosh mentioned that he has tried to contact NYSERDA Camille Warner, he said that she must be on vacation. He did mention that the Town of Bethlehem Solar Law much bigger than the Town of Cambridge and they have zones that allow solar on. They have zoning and Comprehensive Plan.

It was mentioned that 3 towns that have done Solar laws now have moratorium's back in place again.

Councilman Carrino asked Phil Bell about what happen at the school and why Solar was taken off the roof and why not put back on. He mentioned that the condition of the roof had to be fixed and the solar was never put back. Phil mentioned that he was at the meeting to help the Board to create a policy and move forward with Solar.

The Supervisor did mention that there is going to be support group at the county and this will help at County Level just starting to come up with work plan and take everyone's knowledge with towns that really deep into Solar. Supervisor Feder said just discussed on Thursday of last week, nothing in place yet.

Councilman McIntosh says have in hand 2 Solar Laws Town of Williamstown NY and 2023 version of Town of Jackson Solar Law.

Phil Bell mentioned that rely on the policy more than law purpose and what context is for Town of Cambridge, need to decide what is important to the Town of Cambridge and the residents.

Councilman McIntosh says that large projects have to comply but if state doesn't consider Law reasonable doesn't have to accept it.

The Town Board said that they will take everything into consideration that Phil Bell has said.
