Assessor Report

Highway Superintendent Report

Jim Buckley Jr. Highway Superintendent reported that they spent quite a few days busy plowing and sanding roads. They even had the grader out after one mixed precipitation storm to get ice off the roads in places.

- For this last bit of rain, they were busy making repairs and getting equipment ready for spring.
- They did get about 57 ton of salt from Atlantic salt since American Rock Salt is unable to supply any. This should get them through till spring.
- Highway Superintendent went to Advocacy Day in Albany, where they spoke to State Senate and Assembly people about CHIPS funds, the salt problem, and the problems with the Electric Truck Mandate, among other things.
- Washington County has put out a bid for salt. If the prices come back good, we will be
 able to buy off this. If prices are not good, they will still have a chance to buy off OGS
 contract.

Planning Board Report

Planning Board meeting was March 5, 2025 with 3 members present Scott Clark, Valerie Morigerato, Dorothy Yurschak, Secretary Heather Greenawalt and surveyor Jake Keasby

Received information from the Town of Easton on their requirements on what should be listed on the survey maps. Scott Clark said that they would discuss this next meeting that would give everyone time to read and discuss the next meeting.

Brian Larson on King Road came to meeting to have the mylar copy restamped because in was not filed with the County within the 60 days.

Survey was presented for Minor subdivision Copses Farms – Eric Mayer, Jake Keasby the surveyor presented for 257 Wright Rd. tax map #271.-3-1 – 176.60 acres. They will be subdividing out 9.8-acre lot with the house and the barns, the remaining amount of 166.8 acres will remain agricultural land. There was a question on the map of the amount of the agricultural land that will be fixed before next meeting. The septic is on the right side of the house. There was plenty of road frontage. The Planning Board found everything to look good.

Dorothy Yurschak motioned, seconded by Scott Clark to approve the survey map and to move forward to the Public Hearing for 257 Wright Rd. tax map #271.-3-1 for the April 2nd meeting. The next meeting is Wednesday, April 2, 2025

Town Clerk Report

- Still working with Williamson and Law more setting up the accounting software program. Have all the ICS and the NYCLASS account inputted and hoping to do the reports soon. Wendy Ford has come in more and is learning more about the program. Things are moving along.
- The second deadline for taxes February 28th and the remaining amount has been turned over to the Washington County Treasurer, \$115,000. Delinquent tax letters have gone out.
- Copier is not working well and looking for permission to research and find amounts to purchase new copier or lease.

Thank you notes were received from EMS, Food Pantry and the Senior for money budgeted for 2025.

It was mentioned that the County has put out to bid for the Salt to see if they can get a better price. Jim and Travis, the Highway Superintendents have put a lot of work into this so they will not get caught like they did this year.

Solar

Councilman Carrino and Councilman McIntosh have talked and hope to get copy of Schaghticoke law to compare with the Town of Jackson, etc. and see where they differ. Supervisor Fedler suggested that put into larger landscape stuff that block solar farm. Nice privacy fencing and setbacks must be very specific and not decrease the property values.

Councilman McIntosh said that Williamstown Plan out by Watertown description and lengthy of what happens when ownership changes. Town of Jackson has hold harmless clause (at any point in the process of project). Jackson Local Law prohibiting battery storage. Jackson project concern and the hillside, drainage pond, steep and how would you get a fire truck up there.

Supervisor Fedler said when meet up at the County with Fire Coordinator then she will give or send info. Still working on Solar progressing.

The Books were Audited for the Clerk to the Supervisor and the Town Clerk, the Town Board signed off on all books from 2024.
