## **Assessor Report**

Arek Gordon the Assessor was present at the meeting to speak on the Appraisal reassessment trend of 8% across the board to keep the equalization rate at 100%. Everything was 8% increase except new builds. Our rate of change is the same as other towns, the change is based on sales of this Town. Grievance Day is on Wednesday, May 28th 4-8 pm. He said that if there were any questions to contact his office. He said that both the Assessor and the State run the numbers and then they compare on the overall ratio in our area so make sure towns are comparable.

Arek mentioned that now have a .gov address for the Town of Cambridge, which is a requirement by the State. The new web address is townofcambridge.gov. Currently working to get Town of Cambridge in compliance with state for the beginning of September. Should also have separate email addresses for employees, not personal emails.

Matt Konsul was present at the meeting and he had a question of how the playing field is leveled between the Towns. The Supervisor said that the Clerk to the County Supervisor is

responsible for figuring the percentages that are paid throughout the Towns. The numbers are based off the sales, Assessor and State. Arek did say that he has no control over the equalization rate but he does have control over Assessments.

## **Planning Board Report**

Planning Board meeting was May 8, 2025 with 3 members present Scott Clark, Valerie Morigerato, Dorothy Yurschak, Secretary Heather Greenawalt and 4 residents

Chad Gulley and his mother Carol Gulley presented sketch plan for 117 Petteys Rd. tax map #246.-1-39.1 – 34.7 acres and will be subdividing out approximately 3 acres. His mother will be building a house on the lot. Planning Board gave permission to move forward with the survey.

Colleen and Anthony McDonald presented a sketch Plan for proposed subdivision at 85 Darwin Rd. – 262.-1-21 13.4 acres. They are proposing subdividing out 4-to-5-acre lot on the hill behind the vineyard, this is the Ken Denburg house and vineyard. The concerns were the Road frontage was only 65 ft, there is already a road that is used to get to land that is used by local farmer for Agricultural purposes. They did say that the old barn that is near the road way thru could be included in the subdivision. There were also concerns about the distance from the winery building and the property line. They said that need to think about this for the future. Planning Board mentioned that on the survey map if could include the septic and well for the current residence and the new residence. Even if it is possible the neighboring properties wells and septics would be helpful because of problems with past subdivisions. Permission was given to move forward with survey.
