Town Board Meeting November 4, 2024

The Regular Town Board Meeting of Town of Cambridge was duly called, Monday, November 4, 2024 at the Cambridge Town Hall, at 7:30 PM the following were present:

Meeting called to order and Supervisor Fedler led in the Pledge Allegiance to the Flag.

Public Hearing for the Tax Cap Override Local Law 2 2024

Public hearing opened at 7:35 PM

The Supervisor explained that Tax Cap Override is put in place to go over the tax cap. The Supervisor called 3 times if any public comment. With there being none the Public hearing was closed at 7:36PM

Public Hearing 2025 Budget

Public Hearing opened at 7:37 PM

The Supervisor asked if there were any questions about the 2025 Budget. The Supervisor mentioned that there had been a question about raise for the Board and the Supervisor. The Supervisor mentioned that these salaries could not be increased after they were published in the paper.

Alan Davis had comments on page 8 of the budget on the unexpended budget. He wondered if could change DB5110.4 back to the 2024 budgeted amount of \$100,000 rather than \$110,000. The additional increase was requested in order to cover increased costs. He said this would keep the budget under the cap. Tried to explain to him that some of this unexpended is not money left over from last year it is interest that was earned from the investment accounts (NYCLASS and ICS accounts). Because open employee positions, salary and benefit monies remain, not everyone takes insurances. This also caused there to be unexpended dollars. Alan Davis had concerns about the town is holding on to many trucks with 2 pickups and also 6 plow trucks. He wanted to know why they needed so many.

The Supervisor said that the Town has 5 snow plow routes and keeps the 6th for a spare because it is hard to get parts now. Many Towns keep a spare truck now. Approximately 10 years ago the decision was made to keep a spare a pickup truck. The reasoning behind this is so the Highway Superintendent has a truck and the men have a truck to use around town: hauling trailer with lawn mowers to mow cemeteries, fill pot holes, haul the hot box and save miles on the big trucks.

Jonathan Shambo a resident of the Town was at the meeting and had concerns that the pickup was only plowing the intersections and not the roads in between. It was suggested that he contacts the Highway Superintendent when this occurs. Also, a question of why when a property changes hands they can't take the lane off the route for plowing. The Supervisor said that they have tried but there are laws that don't allow the town to drop road. The Town can ask new landowners to give up the lanes but they have the right to say No!

After calling 3 times for comments on the public hearing for the 2025 Budget the Public Hearing was closed at 8:11 PM.
